Duties of Flag States to Implement and Enforce ...

UNCLOS establishes the basic features relating to the exercise of flag State jurisdiction in the implementation of safety regulations. It also regulates the extent to which coastal States may legitimately interfere with navigation by foreign ships in different maritime zones for the purpose of ensuring proper compliance with safety regulations.

FLAG STATE'S DUTIES FOR ENSURING THE IMPLEMENTATION OF THE ...

Flag state delegates most of its responsibilities to classification societies which include regulation implementation and technical duties. As these societies are private organizations and fighting for the market share, they are often criticized for lowering their standards to attract clients and keeping up with the competition.

What are Flag States in the Shipping Industry?

Ship owners and operators have the right to choose their flag state. To attract owners and operators, flag states may offer incentives, such as cheap registration fees, low or no taxes and discounts to fleet registration. Flag states are not just coastal countries, since the Flag Right Declaration of 1921, it has been recognized that all states, including land locked countries, have the right to be used as a flag state.
